# **Emissions reduction targets**

In order to continue our progress to achieving Net Zero, we have adopted the following carbon reduction targets.

We project that carbon emissions will decrease over the next five years to  $106 \ tCO_2 e \ by \ 2028$ . This is a reduction of 25%.



## **Carbon Reduction Projects**

#### **Completed Carbon Reduction Initiatives**

The following environmental management measures and projects have been completed or are currently being implemented since the original 2023 baseline.

Reduction of overall energy use:

- Thermostats programmed to only run during working hours
- LED lighting with automatic sensors
- Unplugging equipment when unused
- Opt for a green/renewable energy tariff

Waste:

- Ensuring no waste to landfill and more waste recycled
- Using sustainable waste disposal companies with electric fleets
- Move from paper documents to online documents
- No single use plastics
- Recycling or reselling used equipment

Travel:

- Allowing a hybrid WFH model
- Encouraging car sharing and/or public transport, where possible
- Actively promote online meetings to reduce overall travel required

#### **Declaration and Sign Off**

This Carbon Reduction Plan has been completed in accordance with PPN 06/21 and associated guidance and reporting standard for Carbon Reduction Plans.
